## 1) SETUP PHASE

The first month is dedicated to the Setup Phase, during which the VP of the Market must appoint at least one (and maximum 5) National Team Leader (NTL).

That NTL will build a committed team of at least 50 National Launching Leaders (NLLs), thereby making the country eligible for the Official Launch Strategy and moving to the VIP Phase.





## 2) VIP PHASE\*

During the 3 months VIP phase there are 3 levels of benefits that members can enjoy depending on their commitment:

- VIP PACK
- POWER HUB
- TOP 100 FOUNDERS

All 50 NLLs in the Setup Phase receive 5 FREE Vyvo Life CoPilot Vouchers in their Packs. (In the Standard Pack \$299)

Upon reaching and starting the VIP PHASE, they will retroactively receive another 5 FREE Vouchers, so they will have 10 vouchers for the next phase.

The 100 Founders will be determined based on the total amount of turnover. A dedicated page will be created where, on a weekly basis, each member will be able to see their position in the 100 Founders Ranking.

\*Requirement for the beginning of the VIP Phase:

Have at least 1 NTL and 50 NLL each with the VIP or Member Pack at the end of the Setup Phase

## 2.2) VIP PHASEPOWER HUB

### **HV Bonus for Direct VIP Packages**

For each **Direct VIP Package** sold, the **Connector** will receive **HV** in their **Power Hub** according to the following progression:

1-9 Packages	<b>x2</b>
<b>10-19</b> Packages	
20+ Packages	<b>x</b> 5

### Example

If at the beginning of the Epoch Mark has **Hub A** as his Power Hub, by selling **1 VIP Pack** of **300 USD** he will receive, at the end of the Epoch, **600 HV in Hub Savings**, credited to **Hub A**.

If during the Epoch Mark has **Hub A** as his Power Hub and sells the **10th VIP Pack** of **300 USD**, at the end of the Epoch he will receive **900 HV in Hub Savings**, credited to **Hub A**.

If during the Epoch Mark has Hub A as his Power Hub and sells the 20th VIP Pack of 300 USD, at the end of the Epoch he will receive 1500 HV in Hub Savings, credited to Hub A.

## 2.3) VIP PHASETOP 100 FOUNDERS\*

### BECOMING A FOUNDER

The share weight for each Founder is calculated in two ways

#### **1.DIRECT SALES VOLUME**

All direct sales made from the date your Hub Console is activated through the last day of the Soft Launch Phase, measured as the total amount in USD. This total determines whether you qualify as one of the Top 100 Founders and remains unchanged throughout the Launch Phase.

#### **2.RANK BY EPOCH**

**Starting from** the **Official Launch phase**, for **every Epoch** in which you **achieve** the **Rank of Premier or higher**, you receive an **additional share bonus**.

Premier 1 Star > 500 Elite 1 Star > 2000
Premier 2 Star > 1000 Elite 2 Star > 2500
Premier 3 Star > 1500 Elite 3 Star > 3000

#### 2.SHARE X MONTH

Starting from the Official Launch Phase, each month, the bonus deriving from the Rank by Epoch relating to the Epochs of the period are added to the Direct Sales Volume; the total is then divided by 100 to determine the monthly shares.

\*Founders' Benefit requirement: By the end of the Soft Launch Phase, there must be at least 80 Founders, each with at least 500 Direct Sales Volumes. If there are fewer than 80, the benefit will be canceled for everyone.

## 2.3) VIP PHASETOP 100 FOUNDERS\*

All Members with at least 500 points are placed on the overall Founders Leaderboard, and the top 100 will become Founders of the Country.

### BENEFIT FOR THE 100 FOUNDER

Be recognized at the Official Launch Event, at the beginning of the Launch Phase

Share 2% of the total sales, each Founder in proportion to his own effort, for the whole 1 year of Official Launch

\*Founders' Benefit requirement: Have at least 80 Founders by the end of the Soft Launch. Fewer than 80 will result in the benefit being canceled for everyone.

### 2.3) VIP PHASETOP 100 FOUNDERS

#### **Example scene: Mark & Gil**

Mark purchases his VIP Bundle 10 days after the VIP Phase begins. Then he has about 80 more days in the VIP Phase plus roughly 90 days of the Soft Launch to maximize his rank in the TOP 100 VIP and become a Founder.

During this period, Mark personally introduces **6 new Members**: **4** with the **VIP Bundle** and **2** with the **Member Bundle**, for a total of  $299 \times 6 = \$1,794$ . This \$1,794 is the figure used to determine Mark's position on the overall leaderboard.

**Gil** joins in the last week of the VIP Phase with her VIP Bundle. Then she has only **one week** left in the VIP Phase plus roughly **90 days** of the Soft Launch to maximize her rank in the **TOP 100 VIP** and become a **Founder**.

Despite the shorter window, she introduces **9 new Members**: **1 with the VIP Bundle** and **8 with the Member Bundle**, for a total of  $299 \times 9 = $2,691$ . This \$2,691 is the figure used to determine Gil's position on the leaderboard.

If **both** finish inside the **Top 100** (subject to other results), their **Shares**, used to calculate final earnings in the **1-year 2% distribution**, would be:

- Mark: 1.794 ÷ 100 = **17** Shares
- Gil:  $2.691 \div 100 = 26$  Shares

If Mark reaches **Rank Premier 1 Star** (500 shares) and **maintains** it for **4 weeks**:

Mark: 1.794 + 2000 (500x4)= 3.794

**So**: 3.794 ÷ 100= **37 Shares**

## 3) SOFT LAUNCH PHASE

Once the VIP Phase ends, the VIP Pack is removed and the Standard Member Pack goes live, which includes only two 1-month vouchers.





## 4) OFFICIAL LAUNCH PHASE

The 1-month Vyvo Life CoPilot Vouchers issued during VIP phase become usable
